Tiffany Jenkins, Outreach Manager, Trauma Intervention Program (TIP) of Southern Nevada



Tiffany shared the extraordinary work the TIP volunteers offer to our community.

Following a traumatic event, the person involved often feels helpless, confused, and in emotional shock. They are confronted with a situation for which they are totally unprepared. Often there is no one available in the immediate aftermath of a tragedy to guide the victims through these difficult hours. The TIP volunteer provides this necessary immediate support until persons involved in the crisis are able to depend on family, friends, neighbors, and others.

When called to scenes, volunteers:

- Provide emotional and practical support
- Help arrange for immediate practical needs depending on the circumstance.
- Assists with notifications to family and friends.
- Serve as a liaison between the victims and emergency/hospital personnel.
- Provide information and referrals to appropriate agencies for on-going assistance.

FOR THOSE INTERESTED IN PURSUING THIS VOLUNTEER OPPORTUNITY

We have a training academy coming up in November. TIP volunteers are required to work (3) 12-hour shifts per month (7A-7P or 7P-7A); they are also required to attend a mandatory 3-hour continuing education meeting on the second **Tuesday of each month** (6:30P - 9:30P); which equals a total of 39 hours of volunteerism per month. **TIP volunteers are** expected to agree to a fullyear commitment to the program after completion of training.



The Trauma Intervention Program (TIP) of Southern Nevada, Inc. is recruiting volunteers in Clark County to serve on our emergency response crisis team.

What is a TIP volunteer?

TIP volunteers are called by local police, fire, medical and hospital personnel to respond to scenes of sudden or unexpected death (natural, homicide, suicide, child, accidental, etc.) violent crimes, sexual assaults, and other traumatic incidents to provide emotional and practical support to family, friends, witnesses and victims.

What are the requirements?

- ·Must be 18 years old ·Clean driving record ·Clean criminal background ·Attend 36-hour training
- ·Pass 3-month field training

Thank you to Lt. Marcus Diaz, Mr. Eslinger and the Marshals for spending your evening with the CPAAA.



Dick Bennett Memorial Community Service Award

The Dick Bennett Memorial Community Service Award is awarded annually to the Las Vegas Metro Police Department Citizens' Police Academy Alumni Association (CPAAA) member who demonstrates the quality and character exemplified by Dick Bennett in community service to the City of Las Vegas and Clark County.

Dick Bennett, who passed away on 6 June 2017, served with distinction as the President of the CPAAA from March 2002 – June 2017. During his tenure, the CPAAA saw its membership increase as well as the money raised to support various police department initiatives.

Dick also worked to raise the awareness of various divisions within the LVMPD to CPAAA membership. The CPAAA has organized trips to prisons, the coroner's office as well as other civic organizations. In addition to the time he devoted to the CPAAA, Dick also served as a LVMPD Volunteer and "leading by example," he volunteered over 22,000 hours of public service to the Police Department.

Each year, the Board of Directors will identify one CPAAA member as the recipient of the Dick Bennett Memorial Community Service Award from the applications submitted. This individual is someone who is not currently serving on the CPAAA Board of Directors; not only an active member of the CPAAA, but also works in the community as a volunteer through the Metro Volunteer Program or other community service organization, which supports the citizens of Las Vegas and the surrounding Clark County. Members in good standing of the CPAAA are encouraged to nominate someone they feel is deserving of the award and applications will be submitted by the end of the current year.

The Dick Bennett Memorial Community Service Award will occur annually at the CPAAA February monthly meeting. The award winner will receive an inscribed plaque presented by the Sheriff commending that individual for his or her service to the LVMPD and the greater Las Vegas community.


